

Puritan migration to New England (1620–1640)

The **Puritan migration to New England** took place from 1620 to 1640, and declined sharply thereafter.¹

They came in family groups rather than as isolated individuals and were mainly motivated by freedom to practice their beliefs.

The Migration primarily came from [East Anglia](#), specifically [Lincolnshire](#), where [John Cotton](#)'s teachings were most received in England.
